- 7. The School shall upload their data to U-DISE System (Unified District Information System for Education) and update it regularly.
- 8. In case of any breach or contravention of any of the provisions of the Affiliation, bye laws of the respective Board or any provisions of the Gujarat Self-financed Schools (Regulation of Fees) Act-2017, and the rules made thereunder or any of the conditions of the NOC, State Government reserves its right to withdraw the NOC.
